

## Agreement To perform volunteer services

### Introduction

The Beneficiary declares that it is an entity for the benefit of which services can be provided by volunteers under Article 42 (1) (1) of the Act of 24 April 2003 on public benefit activities and volunteering.

The Agreement refers to activities related to the organization and operation of the European Athletics Team Championships Silesia 2021, hereinafter referred to as the EVENT, held in the city of Katowice, Chorzów and airports Kraków-Balice and Katowice-Pyrzowice from 17.05 to 01.06.2021. The main organizer of the Event is Stadion Śląski Spółka z Ograniczoną Odpowiedzialnością, hereinafter referred to as the ORGANIZER.

The Beneficiary is responsible for organizing and coordinating volunteers for the Event.

The Volunteer declares that he/she is qualified and meets the requirements necessary to perform the assigned activities.  
The Volunteer declares that his/her health, both mental and physical allows him/her to perform the assigned activities.

Bearing in mind the idea of volunteering, which is based on the voluntary, unpaid performance of activities, as well as taking into account the charitable, auxiliary and complementary nature of the services performed by volunteers, the Parties to the Agreement agree as follows:

### § 1

1. The Beneficiary entrusts the Volunteer and the Volunteer voluntarily undertakes to carry out tasks for the Beneficiary during the EUROPEAN ATHLETICS TEAM CHAMPIONSHIPS SILESIA 2021
2. Volunteer tasks may include activities related to:
  - a. taking care of the team as Team Attaché
  - b. competition administration - i.a. entering competitors' personal data into the system
  - c. competition area - i.a. preparing the stadium for the safe conduct of the competition
  - d. medical area - i. a. support in anti-doping control
  - e. marketing area - i.a. welcome packages, press stand support
  - f. VIP area - i.a. assistance during the opening and closing ceremonies
  - g. logistic area - i.a. assistance in hotels
  - h. accreditation area - i.a. preparation and issuing of accreditations
  - i. transport area - i.a. assistance in coordination of transport of competitors
3. The work of Volunteers is coordinated by a person designated by the Beneficiary or Organizer.

### § 2

1. The parties to the Agreement agree that the services specified in § 1.2 will be performed from 17.05 to 01.06.2021.
2. The services will be provided in Katowice or Chorzów, Katowice-Pyrzowice and Krakow-Balice airports and in other places indicated by the Beneficiary.
3. The Beneficiary shall provide the Volunteer with the preparation necessary to perform the services referred to in § 1 in a professional and safe manner.

### § 3

Because of the nature and idea of volunteering:

1. The volunteer is required to perform the agreed upon activities himself/herself.
2. The volunteer will not be paid for their activities.

### § 4

1. The Beneficiary declares that it has informed the Volunteer of the health and safety risks associated with the services to be performed and the rules for protection from hazards.

2. The volunteer is entitled to personal accident insurance while volunteering.
3. The Volunteer agrees to be tested for Covid virus.

#### § 5

1. The Volunteer declares that he/she agrees to the processing of his/her personal data in relation to the performance of services specified in this Agreement. The administrator of the Volunteer's data is the Beneficiary, the data will be processed in relation to the performed volunteer work during the European Athletics Team Championships Silesia 2021, it will be stored no longer than until 31.12.2021. The Volunteer's data will not be used for automated decision-making (e.g. profiling). In addition, the Volunteer has the right to: request access to his/her personal data from the controller; request correction; request erasure or restriction of processing; request data portability;
2. The Volunteer declares that he/she consents to the taking of photos and film footage related to his/her participation in the Event. He/she also agrees to the free use and publication of his/her image by the Beneficiary, in connection with his/her participation in the Event and performance of volunteer services.

#### § 6

The Volunteer agrees to keep confidential any information he/she obtains during and in connection with the performance of services at the Beneficiary.

#### § 7

The Volunteer is obliged to take care and be responsible for the tools and equipment entrusted to him. The Volunteer is responsible for damaged or lost property of the Beneficiary. In the event that the Volunteer has taken his/her volunteer kit and fails to show up at the time and place of the task, the Volunteer is required to return the equipment received.

#### § 8

1. No later than one month from the date of completion of services, the Volunteer will receive a certificate from the Beneficiary attesting to his/her participation in volunteering.
2. The Volunteer may, up to 6 months after the end of the volunteer service, ask the Beneficiary for a written opinion on the volunteer's performance.

#### § 9

For damages caused in connection with the performance of services specified in the Agreement, the Parties shall be liable in accordance with the rules set forth in the Act of 23 April 1964. - Civil Code.

#### § 10

In matters not regulated by this Agreement and the provisions of the Act on public benefit activity and volunteerism the provisions of the Act of 23 April 1964 shall apply. - Civil Code.

#### § 11

Any amendments to the Agreement shall be made in writing under pain of nullity.

#### § 12

The parties declare that in case of a dispute in connection with the execution of this agreement they will strive to settle it amicably, and in case of lack of agreement the dispute will be settled by a court having jurisdiction over the Beneficiary's seat.

#### § 13

1. The Parties agree that the Agreement may be terminated unilaterally by each of the Parties upon one day's notice. Termination of the Agreement requires submission, by the terminating party, of a statement on termination of the Agreement. The declaration may be submitted in paper or electronic form.
2. On termination of the Agreement in the manner specified in item 1 § 14, the Volunteer loses the possibility of using the benefits specified in § 4 and 5 of this Agreement, which also means the obligation to return the received equipment to the Beneficiary no later than on the date of expiration of the Agreement.

#### § 14

The volunteer voluntarily relieves the Beneficiary of travel expenses to the event and meetings.

#### § 15

The Agreement has been drawn up in two identical copies, one for each Party.
